

INCLUDED PARTS

- (1) HE-2 Inclinometer
- (1) Micro USB charging cable

(1) Mounting bracket (1) 120V USB charger

SET-UP

- 1) Use the USB charger and cable to fully charge the HE-2 Inclinometer before use. The red light will illuminate while charging. The white/blue light will illuminate when complete.
- 2) While the unit is charging, measure the width and length of your RV's wheel spacing. You want the center-tocenter spacing but it's usually easier to measure from the inside of one wheel to the outside of the other wheel as shown below. Measure in inches or centimeters and write the value down.



- The <u>D</u>isplay has 15 different screens. The screen number is shown at the top right of the Display.
 a. Screens 1-6 are for normal use. Screens 7-15 are for Setup Mode.
- 4) Once the HE-2 is charged, press the Power button for 2 seconds. The unit will turn on.
- 5) Use the UP arrow button to navigate to screen #7 "Admin Mode"

SET LENGTH

- 6) Press the ENTER button and you will be on screen #8 "Set Length".
- 7) Press ENTER again to edit the length value.
- 8) Then press the UP or DOWN buttons to set the correct length that you measured in step #2.
- 9) Press ENTER one more time to exit the edit mode.

SET WIDTH

- 10) Press the UP arrow to navigate to screen #9 "Set Width"
- 11) Press ENTER to edit the width value.
- 12) Then press the UP or DOWN buttons to set the correct width that you measured in step #2.
- 13) Press ENTER one more time to exit the edit mode.

SET TIRE BLOCK HEIGHT

- 14) Press the UP arrow to navigate to screen #10 "Set Block Ht."
- 15) Press ENTER to edit the tire block height value.
- 16) Then press the UP or DOWN buttons to set the correct block height.
 - a. <u>The unit of measure</u> (inches or centimeters) must be the same as the length and width measurements entered on screens #8 and #9.
 - b. For interlocking blocks, do not measure the part that inserts into the other block.
- 17) Press ENTER one more time to exit the edit mode.
- 18) Wait 10 seconds for the unit to exit Admin Mode and save the values.

INSTALLATION

- 19) Find a suitable installation location for the HE-2. It must be within 45° of flat level to maintain accuracy.
- 20) Install the mounting bracket with double-sided tape or screws.
- 21) Make sure the HE-2 can be easily removed and installed into the bracket.

RV FLOOR TO INSTALLED POSITION CALIBRATION

- 22) Make sure the unit is ON.
- 23) Place the unit on the floor or other surface that is the one to be level when parked. Try to be accurate with the rotation of the HE-2 as it will affect accuracy. The FRONT arrow must point to the front of the RV.
- 24) Press the UP arrow to navigate to screen #7 "Admin Mode"
- 25) Press ENTER to get to menu #8
- 26) Press UP and navigate to screen #12 "Calibration, Level Surface"
- 27) Press ENTER for 2 seconds. A 3-second countdown timer will commence. At 0, the calibration will be performed. Do not move or bump the HE-2 during calibration. "Complete" will be shown when finished.
- 28) Now place the HE-2 back into the previously installed mounting bracket. (Step 19)
- 29) You should be on screen #13 "Calibration Installed Surface". If not, press the up or down arrows to navigate to menu #13.
- 30) Press ENTER for 2 seconds. A 3-second countdown timer will commence. At 0, the calibration will be performed. Do not move or bump the HE-2 during calibration. "Complete" will be shown when finished.
- 31) SETUP IS COMPLETE

USING THE INCLINOMETER

- 1) Press the power button below the Heliosure logo for 2 seconds. The unit will turn on.
- 2) 1 of 6 display screens will be shown. The screen number is shown at the top right of the Display.
 - a. #1 CUSTOMER calibrated HEIGHT. This means it uses the information from steps #21-#29. The unit of measure is the same as was used in Length, Width, and Block Height.
 - b. #2 FACTORY calibrated HEIGHT. Relies only on the factory calibration.
 - c. #3 CUSTOMER calibrated BLOCKS. This means it uses the information from steps #21-#29. Unit of measure is Quantity of blocks.
 - d. #4 FACTORY calibrated BLOCKS. Relies only on the factory calibration. Unit of measure is Quantity of blocks.
 - e. #5 **CUSTOMER** calibrated **PITCH AND ROLL**. This means it uses the information from steps #21-#29. The unit of measure is angular Degrees.
 - i. Pitch shows back to front. Positive numbers mean the front is higher than the rear.
 - ii. Roll shows left to right. Positive numbers mean the right is higher than the left.
 - f. #6 FACTORY calibrated PITCH AND ROLL. Relies only on the factory calibration.
 - i. Pitch shows back to front. Positive numbers mean the front is higher than the rear.
 - ii. Roll shows left to right. Positive numbers mean the right is higher than the left.
- 3) Press and hold the POWER button for 3 seconds to turn off the HE-2. It will also automatically power after a preset time. Programmable on screen #14.

OPTIONAL

- Press ENTER if you'd like to FREEZE the display. This allows you to remove the display from the mounting bracket and use it outside when placing blocks. It eliminates the need to memorize how many blocks per wheel. Press ENTER again to unfreeze.
- 2) While on any display screen, pressing ENTER for 2 seconds will save that display screen (#1-6) as the default screen for each subsequent power-up.
